1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - provide employment information for June to August 2016 relating to Community Services

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
 - (1) that the following employment information for June to August 2016 relating to Community Services be noted:-
 - attendance statistics
 - occupational health
 - accident/incident statistics
 - discipline, grievance and Dignity at Work cases
 - analysis of leavers and exit interviews
 - Staffing Watch as at 11 June 2016

3. Background

3.1. As part of the Council's performance management arrangements, regular workforce monitoring reports are submitted to Committee. This report for Community Services provides information on the position for June to August 2016.

4. Monitoring Statistics

4.1. Attendance Statistics (Appendix 1)

Information on absence statistics is analysed for the month of August 2016 for Community Services.

The Service absence figure for August 2016 was 4.3%, an increase of 0.5% when compared to the previous month and is 0.7% higher than the Council-wide figure. Compared to August 2015, the Service absence figure has increased by 0.3%.

Based on the 2016/2017 annual trend, and the absence figures at August 2016, the overall annual average absence for the Service for 2016/2017 is 5.4%, compared to a Council-wide average figure of 4.3%.

For the financial year 2016/2017, the average days lost per employee within the Service equates to 12.3 days, compared with the average figure for the Council of 9.4 days per employee.

4.2. Occupational Health (Appendix 2)

In terms of referrals to occupational health, which include medical examinations and physiotherapy, overall 249 referrals were made this period. This represents an increase of 25 when compared with the same period last year.

4.3. Accident/Incident Statistics

There were 10 accidents/incidents recorded within the Service this period, a decrease of 6 when compared to the same period last year.

4.4. Discipline, Grievance and Dignity at Work (Appendix 2)

During the period, 25 disciplinary hearings were held within the Service, a decrease of 26 when compared to last year. During this period there were 3 appeals heard by the Appeals Panel. There were 2 Grievance hearings held within the Service this period and this figure has increased by 2 when compared to the same period last year. One Dignity at Work hearing was held within the Service this period and this figure remains unchanged when compared to the same period last year.

4.5. Analysis of Leavers (Appendix 2)

There were 34 leavers in the Service this period, an increase of 5 when compared with the same period last year. One exit interview was conducted.

5. Staffing Watch (Appendix 3)

There was an increase of 23 employees in post from 12 March 2016 to 11 June 2016.

6 Employee Implications

8. Other Implications
