1 Declaration of Interests

2 Minutes of Previous Meeting

3 Revenue Budget Monitoring 2007/2008 - Social Work Resources

A joint report dated 14 December 2007 by the Executive Directors (Finance and Information Technology Resources) and (Social Work Resources) was submitted comparing actual expenditure at 30 November 2007 against budgeted expenditure for 2007/2008 for Social Work Resources.

6 Staffing Proposals - Day Care for Older People and Staff Training Centre

A joint report dated 13 December 2007 by the Executive Directors (Corporate Resources) and (Social Work Resources) was submitted on the staffing required for the Day Care Facility for Older People and Staff Training Centre located on Bothwell Road, Hamilton.

The Council, in partnership with Alzheimers Scotland and NHS Lanarkshire, would develop a training strategy to deliver the appropriate care to individuals suffering from or affected by dementia.

In order to provide the necessary support, it was proposed that a post of Senior Day Care Officer SCP 38-50 (£19,484 to £23,265) be established.

The total cost involved in establishing the above post would be met from within existing budgets.

The Committee decided: that a post of Senior Day Care Officer graded SCP 38-50

(£19,484 to £23,265) be established.

7 Mental Health Services Staffing

A joint report dated 3 December 2007 by the Executive Directors (Corporate Resources) and (Social Work Resources) was submitted on the staffing required to support individual community based care packages and to build a community support infra-structure for adults with mental health problems being discharged from long stay hospitals.

In order to provide the necessary support, it was proposed that 3 posts of Social Worker/Mental Health Officer graded SCP 68-80 (£28,760 to £34,381) be established.

The total cost of £132,021 in establishing the above 3 posts would be met from Resource Transfer monies from NHS Lanarkshire and NHS Greater Glasgow and Clyde.

The Committee decided: that 3 posts of Social Worker/Mental Health Officer graded

SCP68-80 (£28,760 to £34,381) be established.

10 Research Findings - Identifying the Care Needs that Exist within Minority Ethnic Communities Living in Lanarkshire

A report dated 5 December 2007 by the Executive Director (Social Work Resources) was submitted on research undertaken in partnership with North Lanarkshire Council and NHS Lanarkshire to identify the care needs, both formal and informal, of vulnerable people from ethnic minority communities living in Lanarkshire.

The research report had been launched at an event in November and identified 14 key recommendations for partners in the following 4 main areas:-

- promoting awareness of services
- ensuring the provision of culturally sensitive services
- blending mainstream provision with community provision
- improving how information on ethnicity was gathered and used

Work had commenced within Social Work Resources to consider the report recommendations and develop an action plan to implement the key findings.

The Committee decided: that the report be noted.

11 Justice Services Inspection Report

A report dated 13 December 2007 by the Executive Director (Social Work Resources) was submitted on the Criminal Justice Inspection Report which had been signed off by the Social Work Inspection Agency (SWIA). Following the inspection of Criminal Justice Services in North and South Lanarkshire Councils undertaken in 2005, the SWIA had been provided with an update on progress made in Summer 2007 and had paid a final visit, meeting with both Councils, in October 2007.

The specific areas in which SWIA had shown an interest were:-

- risk assessment
- ♦ case recording
- enforcement and compliance
- ♦ community service
- throughcare and quality assurance

The Lanarkshire Community Justice Authority (CJA) would have responsibility for developing a performance reporting framework which would continue to monitor some of the above issues.
