## 4 Civic Government (Scotland) Act 1982 (As Amended) - Application for a Temporary Public Entertainment Licence

---

A report dated 11 September 2018 by the Executive Director (Finance and Corporate Resources) was submitted on an application for a temporary public entertainment licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was not present but was represented by C Loudon, Solicitor and C Spencer.

Comments opposing the application had been received from Councillors Campbell, Cooper and Dorman and local residents, with K Mackenzie, Lawyer, S Thompson and D Scott present and heard respectively.

Comments supporting the application had been received from local residents.

M Clinton, Licensing Standards Officer, J Gillies, Grounds Services and G Nelson, Environmental Services were also present and heard respectively.

Councillor Lennon, seconded by Councillor Miller, moved that the application be granted. Councillor McGuigan, seconded by Councillor Donnelly, moved as an amendment that the application be refused. On a vote being taken by a show of hands, 5 members voted for the amendment and 16 for the motion which was declared carried.

**The Committee decided:** that the application by Spencer's £1 Funfairs, 212 Strathclyde Street, Dalmarnock and R K Spencer for a temporary public entertainment licence at George Allan Park Car Park, Strathaven be granted subject to the conditions specified by the Executive Director (Finance and Corporate Resources).
