Subject: Revenue Budget 2011/2012

1. Purpose of Report

1.1. The purpose of the report is to:-

- ◆ Outline the outcome of the budget process and the content of the Revenue Budget for 2011/12.
- ♦ Adopt the Revenue Budget for 2011/12 as summarised at Section 4 of this report and the allocation to each Resource as shown in Appendix 1.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
 - (1) that the Revenue Budget as proposed for 2011/12 be endorsed
 - that it be recommended to the Executive Committee that the Revenue Budget for 2011/12 as summarised in Section 4.3 of this report, and the base allocation to Resources at Appendix 1 be adopted.

3. Background

3.1. Principles Applied in Budget Formation

The local government finance settlement provided by the Scottish Government in December 2010 provided grant settlement figures for the financial year 2011/12. The receipt of this information allows the budget process to be finalised with a degree of certainty.

- 3.2. The process to identify the level of expenditure needed to maintain the Council's services in 2011/12 started in early 2010. Using the 2010/11 budget as a starting point to reflect the Council's priorities, projections were made into 2011/12. A number of adjustments were applied to core service budgets through the rollover process to include known commitments and additional budget pressures. It was agreed that the requirement for savings would be met through a savings prioritisation exercise which, through a relative scoring matrix, streamlined the savings options to be considered as part of the 2011/12 budget process.
- 3.3. The next stage was the presentation and approval of efficiency savings (Executive Committee, 31 January 2011). These totalled £25.137 million and were incorporated in a round of Resource Special Committee papers on 4 February 2011.

The Council's strategy of seeking efficiency savings is consistent with the principles of best value and with the obligations of the Scottish Government's efficient government initiative.

4. Total Budget 2011/12

- 4.1. The total budget for 2011/12 is now £715.521 million. This is the figure reported to the Executive Committee on 4 February 2011.
- 4.2. The detailed allocation of the budget to each Resource, including rollover adjustments, is shown at Appendix 1 for the consideration of the Council in finalising the level of Council Tax. The statutory deadline for this announcement is 11 March. However, for South Lanarkshire Council, the Council Tax will be set at the Council Meeting on 10 February 2011.
- 4.3. The main figures from Appendix 1 are summarised below:

5. Government Grant

- 5.1. An updated figure for Government Grant to the Council for year 2011/12 was provided in December 2010. The base for the overall grant allocation is the 2011/12 Total Revenue Support figure, which is calculated using an extensive formula, including adjustments which take account of each council's ability to raise taxes locally.
- 5.2. The level of grant from the Government includes the effect of the 'Floor Adjustment' made by the Scottish Government as part of the grant allocation formula. Previously, the floor adjustment ensured that all Council's received a minimum increase in grant. However, in 2011/12, the adjustment is to ensure that no council exceeds a maximum level of grant decrease. The maximum level of grant decrease has been set at 4.5%. Through the floor adjustment, South Lanarkshire contributes £1.957m in 2011/2012.
- 5.3. The Total General Revenue Funding figure of £589.021 million is part of a package which individual councils will have to agree to, including a council tax freeze, or be subject to a higher level of grant cut, as detailed in the report to the Executive Committee on 16 December 2010.
- 5.4. Grant for 2011/12 now totals £589.021 million and consists of the following:

5.5. Government grant and non-domestic rates income together meet over 80% of the Council's current expenditure and related loan charges. Because of this relatively large proportion from central sources, changes in grant levels have a significant impact on the amount of funding to be found from the local community.

6. Governance Arrangements

- 6.1. The responsibilities of the Performance and Review Scrutiny Forum include overseeing the Council's strategy and approach to Best Value, improvement and performance management, as well as the response to efficient government. This includes the presentation of service review reports, Statutory Performance Indicator results and the Council's responsibilities in respect of Public Performance Reporting.
- 6.2. The Financial Resources Scrutiny Forum continues its role of reviewing all financial activity and will continue to develop its programme of budget reviews during the year ahead.
- 6.3. The Risk and Audit Scrutiny Forum receives both internal and external audit reports.
- 6.4. Each Committee receives reports on its Resource's financial performance at all meetings throughout the year. The Executive Committee takes an overview of the Council's financial position on a monthly basis.

- 10.2. Trade union consultation has been undertaken. In addition, building on work done in previous years, a public consultation exercise was carried out throughout December 2010 / January 2011. Public consultation on the budget has been carried out using members of the Citizens' Panel. In addition, budget consultation events have taken place with representatives of Disability Groups in the South Lanarkshire area, Lanarkshire Ethnic Minority Action Group, the Council's Employee Forums, South Lanarkshire Youth Forum and Seniors Together. Feedback on the outcome of the consultation was summarised and provided to Members in a briefing paper "Budget Consultation 2011" on 28 January 2011.
