Subject: Institute of Cemetery and Crematorium Management

(ICCM) Best Value Charter Assessment Scheme

1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - ◆ Advise the Committee of the standing of South Lanarkshire Council's Bereavement Services within the Institute of Cemetery and Crematorium Management (ICCM) Best Value Charter Assessment Scheme.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendations:-
 - (1) that the ICCM Assessment of Bereavement Services be noted.

3. Background

- 3.1. The ICCM collates information annually from organisations which provide burial or cremation services or both. In 2008 123 organisations completed assessments.
- 3.2. An assessment template comprising 23 sections is completed by each organisation; the assessment includes the evaluation of procedures, operational activities, memorialisation, health and safety (a full list of the sections is attached at Appendix A).
- 3.3. Each section is scored and the results collated to provide a national ranking table for burial services, cremation services and a combined score for those organisations providing both.

4. Current Position

4.1. The current standing of South Lanarkshire Council's Bereavement Services for the provision of services in the various categories is shown in the following tables:-

- 4.2. Areas where no points were scored and therefore areas for potential improvement/investment include the following:-
 - ◆ Public performance reporting e.g. no newsletter published, no information boards in public places such as libraries, no "trail guide" leaflets particularly where cemeteries/churchyards are close to other places of interest.
 - Senior members of staff do not have the ICCM diploma.
 - ♦ Although the Council has IiP accreditation and the service has recently been awarded ISO accreditation the service lacks Charter Mark, EFQM and ICCM excellence accreditation.
 - Currently there is no 24 hour booking service although this is being investigated.
 - No refrigerated coffin storage within the authority.

5. Proposals

The Service has developed an improvement plan to ensure it continues to maintain its high standards. The plan includes:-

- working towards Charter Mark accreditation;
- continuing to develop 24 hour booking;
- continuing to implement a programme of information and signage at access points to cemeteries;
- consideration of the financial implications of developing other areas of the service to improve the experience for service users which in turn would reflect on future assessments of services provided.
