- ♦ 4 companies had been assisted by the West of Scotland Loan Fund which had safeguarded 79 jobs and helped to generate £2.54 million in additional sales
- ♦ 18 businesses had been assisted by the Lanarkshire Sustainable Business Programme which had created/safeguarded 138 jobs and helped to generate £2.52 million in additional sales
- ♦ 16 businesses had been assisted by Lanarkshire Business Training Support which had helped to generate £1.5 million in additional sales

♦ the Property Information Team had been assisting with the asset transfer including town halls, public halls, museums, stores, country parks, community wings and libraries, to the South Lanarkshire Leisure and Culture Trust which came into effect on 1 October 2010
