**Licensing of Second-Hand Dealers** 

## 1. Purpose of Report

1.1 The purpose of the report is to:-

 consider an amendment to the existing Resolution for the licensing of secondhand dealers.

## 2. Recommendation(s)

- 2.1 The Committee is asked to approve the following recommendation(s):-
  - (1) that second-hand dealing in the goods listed in Paragraph 4.2 now be licensed; and
  - (2) that the draft Resolution for the Licensing of Second-Hand Dealers, as detailed in Appendix 1, be approved.

#### 3. Background

- 3.1 At present a Second-Hand Dealer's licence is required when a person deals in any of the following second-hand goods:
  - Motor vehicles, motor vehicle spares and parts
  - ♦ Motor cycles and parts thereof
  - ♦ Caravans, motor homes and parts thereof
  - ♦ Bicycles
  - ♦ Domestic appliances
  - ♦ Furniture
  - ♦ Jewellery, antiques, clocks, watches, gold, silver, medals, coins
  - Musical instruments
  - General household effects
  - ♦ Televisions and radios
  - Video recorders and DVD players
  - ♦ Toys
  - ♦ Tradesmen's tools and equipment
  - Photographic and cinematic equipment
  - ◆ Telephonic instruments including mobile phones, fax machines and associated equipment
  - ♦ Computer hardware and software including handheld computer games
  - ♦ DVDs, video cassettes and other recording or playback audio mediums

#### 4. Present Position

- 4.1 The current Second-Hand Dealers' Resolution was last reviewed in 2005. In light of increased use of technology and experience since that time, it is now considered appropriate to review the list of second-hand goods included in the Resolution.
- 4.2 The proposed additional second-hand goods to be included are as follows:-
  - (1) Motor vehicles, motor vehicle spares and parts **Add "including tyres"**
  - (2) Motor cycles and parts thereof **Add "including tyres"**
  - (3) Furniture
    Add "including mattresses, headboards, pillows and cushions"
  - (4) Video recorders and DVD players

    Amend to "Audio/Video players and recorders"
  - (5) Computer hardware and software including hand held computer games Amend to "Computer hardware, games hardware and related software"
  - (6) DVDs, video cassettes and other recording or playback audio mediums Amend to "DVDs, CDs and other audio/video playback or recording mediums"
  - (7) Clothing
- 4.3 If the Committee wishes these additional items to be licensed, then the current Resolution will require to be amended and a draft Resolution is attached as Appendix 1. The amended and additional items have been highlighted in bold above.
- 4.4 In terms of Section 9 of the Civic Government (Scotland) Act 1982, appropriate notice of any amendments to the Resolution will require to be given in the press for a statutory period of 28 days. Once that process has been completed, a further report requesting approval for the Final Resolution will be submitted to Committee.

#### 7. Other Implications

# Civic Government (Scotland) Act 1982 Licensing of Second-Hand Dealers

## **Draft Resolution**

South Lanarkshire Council, in terms of Section 9 of the Civic Government (Scotland) Act 1982, resolves that as from a date not less than 9 months from the date of the making of this Resolution, the following categories of Second-Hand Dealing within South Lanarkshire shall require to be licensed and regulated in accordance with the provisions of Sections 24 to 27 (inclusive) of the said Act:-

- 1 Motor vehicles, motor vehicle spares and parts including tyres
- 2 Motor cycles and parts thereof including tyres
- 3 Caravans, motor homes and parts thereof
- 4 Bicycles
- 5 Domestic appliances
- 6 Furniture including mattresses, headboards, pillows and cushions
- 7 Jewellery, antiques, clocks, watches, gold, silver, medals, coins
- 8 Musical instruments
- 9 General household effects
- 10 Televisions and radios
- 11 Audio/video players and recorders
- 12 Toys
- 13 Tradeperson's tools and equipment
- 14 Photographic and cinematic equipment
- Telephonic instruments including mobile phones, fax machines and associated equipment
- 16 Computer hardware, games hardware and related software
- 17 DVDs, CDs and other audio/video playback or recording mediums
- 18 Clothing

For the purposes of clarification all previous Second-Hand Dealer resolutions will be revoked from the date this resolution is passed.
