1. Purpose of Report

1.1. The purpose of the report is to:-

◆ provide information on the progress of the capital programme for Housing and Technical Resources (HRA) for the period 1 April 2009 to 2 October 2009.

 - that the Housing and Technical Resources (HRA) capital programme of £40.441 million, and expenditure to date of £17.835 million be noted.

- 3.1. This is the second capital monitoring report presented to the Housing and Technical Resources Committee for the financial year 2009/2010. Further reports will follow throughout the financial year.
- 3.2. The report details the financial position for Housing and Technical Resources (HRA) on Appendix A.

5. Financial Implications

5.1. The total capital programme for Housing and Technical Resources (HRA) for 2009/2010 is £40.441million. Anticipated spend to date was £18.168million, and £17.835million has been spent (44.10% of full budget). This represents a position of £0.333million behind profile. This time last year £14.977million was spent (38.86%).
