# 2 Minutes of Previous Meeting

## 3 Kerbcraft Road Safety Training Initiative

A report dated 31 May 2016 by the Executive Director (Community and Enterprise Resources) was submitted on the progress of the Kerbcraft Road Safety Training Initiative within South Lanarkshire.

The Kerbcraft Road Safety Training Initiative was an on-road pedestrian training scheme which had been introduced to the Council in 2004.

6 primary schools had completed the Kerbcraft Training during the period August to December 2015. 7 schools had, or were due to, participate between January and summer 2016 and a further 6 schools were scheduled to commence their training in August 2016.
