1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - provide information on the progress of the capital programme for Housing and Technical Resources (excl HRA) for the period 1 April 2008 to 23 December 2008.

 - (1) that the Housing and Technical Resources (excl HRA) capital programme of £9.976million, and expenditure to date of £3.302million be noted.

- 3.1. This is the third capital monitoring report presented to the Housing and Technical Resources Committee for the financial year 2008/2009. Further reports will follow throughout the year.

5. Financial Implications

5.1. The total capital programme for Housing and Technical Resources (excl HRA) for 2008/2009 is £9.976million. Anticipated spend to date was £4.127million, and £3.302million has been spent (33.10% of full budget). This represents a position of £0.825million behind profile. This time last year £3.230million was spent (38.80%).
