Subject: Authorised Providers List - Social Care

1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - Recommend the inclusion of 4 new providers, as listed in Appendix 1, who have completed the accreditation process since the last report to Committee.
 - Recommend the amendments to the listing of 3 providers, as listed in Appendix 2.
 - Recommend the closure of the list to providers of Homecare Services for older people and adults except through the tender process or where there is a change of ownership.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
 - (1) that the Committee approve the 4 new providers listed in Appendix 1 for inclusion on the list.
 - (2) that the Committee approve the 3 providers listed in Appendix 2 for amendments to their current categories on the list.
 - (3) that the Committee approve the closure of the list to providers of Homecare Services for older people and adults except through the tender process or where there is a change of ownership.

3. Background

- 3.1. The accreditation process for inclusion on the list has been completed for 4 new providers. Having considered their applications, sought references and consulted Corporate Resources, the Executive Director, Social Work Resources, is satisfied that the relevant criteria is met for the service types and user groups outlined in Appendix 1.
- 3.2. Three providers on the list, as listed in Appendix 2, have requested amendments to their current categories on the list. The appropriate checks have been conducted to allow approval.
- 3.3. Social Work Resources Committee of 8 March 2006 approved, under Standard Order 14, to invite tenders for the purchase of Homecare Services. In order to achieve the savings to the Council in bureaucracy and manage the transition to fewer providers, approval is sought to close the list to providers of Homecare Services for older people and adults, except through the tender process or where

there is a change of ownership. There are currently 35 providers of Homecare Services for older people and adults.

4. Employee Implications

4.1. There are no personnel implications for the Council arising from this report.

5. Financial Implications

5.1. It is anticipated that the closure of the list to providers of Homecare Services for older people and adults will ensure savings to the Council in bureaucracy.

6. Other Implications

6.1. There are no other implications for the Council arising from this report.

7. Consultation

- 7.1. Service Managers across the Resource have been consulted regarding the accreditation.
- 7.2. The proposal to close the list to providers of Homecare Services has been discussed at the Authorised Providers Network of Homecare Providers and was broadly welcomed.
