## 7 Civic Government (Scotland) Act 1982 (As Amended) - Consideration of Suspension or Revocation of Private Hire Car Driver's Licence No 422

A report dated 7 November 2017 by the Executive Director (Finance and Corporate Resources) was submitted proposing that consideration be given to whether private hire car driver's licence No 422 should be suspended or revoked.

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the licence holder who was present. A letter of complaint had been received from Police Scotland and Sergeant Tomlinson was heard.

Councillor Miller, seconded by Councillor Brown, moved that the licence be revoked with immediate effect. Councillor Wilson, seconded by Councillor Logan, moved as an amendment that the licence be suspended with immediate effect for the remainder of the period of the licence. On a vote being taken by a show of hands, 13 members voted for the amendment and 9 for the motion. The amendment was declared carried.

The Committee decided:

that private hire car driver's licence No 422 for the Cambuslang and Rutherglen zone be suspended with immediate effect for the remainder of the period of the licence.

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was not present or represented. A letter of complaint had been received from Police Scotland.

The Committee decided:

that private hire car driver's licence No 621 for the Hamilton zone be revoked with immediate effect.

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was not present or represented. An objection had been received from Police Scotland.

The Committee decided:

that the application for the renewal of private hire car driver's licence No 621 in the Hamilton zone be refused.
