1 Declaration of Interests

2 Minutes of Previous Meeting

3 Application HM/06/0489 - Erection of Double Garage and Associated Fencing at 1 Gibb Court, Stonehouse

A report dated 6 February 2007 by the Executive Director (Enterprise Resources) was submitted on planning application HM/06/0489 by G Mack for the erection of a double garage and associated fencing at 1 Gibb Court, Stonehouse.

The Committee decided: that planning application HM/06/0489 by G Mack for the erection of a double garage and associated fencing at 1 Gibb Court, Stonehouse be granted subject to the conditions specified in the Executive Director's report.

4 Application HM/06/0813 - Erection of Residential Development (12 units) at Government Offices, Calder Street, Blantyre

A report dated 6 February 2007 by the Executive Director (Enterprise Resources) was submitted on planning application HM/06/0813 by W Reid for the erection of a residential development (12 units) at Government Offices, Calder Street, Blantyre.

The Committee decided: that planning application HM/06/0813 by W Reid for the erection of a residential development (12 units) at Government Offices, Calder Street, Blantyre be granted subject to the conditions specified in the Executive Director's report.

5 Application HM/06/0528 - Alterations and Change of Use to Form 2 Self-Catering Living Accommodations (Retrospective) at Former Poultry Breeding Site, Manse Brae, Dalserf

A report dated 5 February 2007 by the Executive Director (Enterprise Resources) was submitted on planning application HM/06/0528 by D and A Kilgarif for alterations and change of use to form 2 self-catering living accommodations (retrospective) at former poultry breeding site at Manse Brae, Dalserf.

The Committee decided:

- (1) that planning application HM/06/0528 by D and A Kilgarif for alterations and change of use to form 2 self-catering living accommodations (retrospective) at former poultry breeding site at Manse Brae, Dalserf be refused for the reasons detailed in the Executive Director's report; and
- (2) that appropriate enforcement action be taken in the event that the unauthorised residential use was not stopped within 2 months and works undertaken to ensure that the buildings changed to use as ancillary accommodation to the main house within 3 months.

6 Application HM/06/0832 - Alterations and Part Change of Use of Existing Shop to Form Hot Food Delivery Service and Erection of Flue (Retrospective) at 34 Annsfield Road, Hamilton

A report dated 23 January 2007 was submitted on planning application HM/06/0832 by N Hussain for alterations and part change of use of existing shop to form hot food delivery service and erection of flue (retrospective) at 34 Annsfield Road, Hamilton.

The Committee decided:

- (1) that planning application HM/06/0832 by N Hussain for alterations and part change of use of existing shop to form hot food delivery service and erection of flue (retrospective) at 34 Annsfield Road, Hamilton be refused for the reasons detailed in the Executive Director's report; and
- (2) that, in the event that the unauthorised flue was not removed within 1 month, an Enforcement Notice be served on the owner/occupier of the premises to secure its removal with a period of 1 month allowed for compliance.

7 Application HM/06/0762 - Erection of Fence to Front and Side of House (Retrospective) at 15A Whistleberry Drive, Hamilton

A report dated 24 January 2007 by the Executive Director (Enterprise Resources) was submitted on planning application HM/06/0762 by J Nicoll for the erection of a fence to the front and side of house (retrospective) at 15A Whistleberry Drive, Hamilton.

The Committee decided:

- (1) that planning application HM/06/0762 by J Nicoll for the erection of a fence to the front and side of house (retrospective) at 15A Whistleberry Drive, Hamilton be refused for the reasons detailed in the Executive Director's report; and
- (2) that, in the event that the fence was not reduced in height within 1 month, an Enforcement Notice be served on the owner/occupier to ensure that the height was reduced in stages to meet the required visibility splay for the driveway with a period of 1 month allowed for compliance.

8 Enforcement Action - Unauthorised Timber Decking and Associated Fencing at 23 Croft Wynd, Uddingston

A report dated 25 January 2007 by the Executive Director (Enterprise Resources) was submitted on unauthorised timber decking and associated fencing at 23 Croft Wynd, Uddingston.

Planning consent had been granted for a 2 storey side extension with a condition that a 1.7 metre fence was to be erected around the boundary at ground level. Complaints had since been received regarding the construction of unauthorised timber decking and associated fencing within the boundary of the property. Discussions with the owner had failed to secure the removal of the unauthorised decking structure. It was proposed, therefore, that enforcement action be taken to secure the removal of the decking and associated fencing.

The Committee decided:

- (1) that an Enforcement Notice be served on the owners/occupiers of 23 Croft Wynd, Uddingston to secure the removal of the unauthorised decking and associated fencing; and
- (2) that the Notice take effect within 1 month of the date of service with a period of 1 month allowed for compliance.

11 HMle Report - St Mark's Primary School, Hamilton

A report dated 30 January 2007 by the Executive Director (Education Resources) was submitted on the outcome of the inspection of St Mark's Primary School, Hamilton made by Her Majesty's Inspectorate of Education (HMle). The inspection had taken place in June 2006 as part of a national sample of primary education and the inspection report had been published on 24 October 2006.

Education Resources' employees would ensure that the recommendations contained within the report were followed up and that appropriate support was made available to the school.
