1. Purpose of Report

1.1. The purpose of the report is to:-

◆ provide information on the progress of the capital programme for Housing and Technical Resources (HRA) for the period 1 April 2008 to 20 February 2009.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):
 - that the Housing and Technical Resources (HRA) capital programme of £38.543million, and expenditure to date of £30.272million be noted.

- 3.1. This is the fourth capital monitoring report presented to the Housing and Technical Resources Committee for the financial year 2008/2009.
- 3.2. The report details the financial position for Housing and Technical Resources (HRA) on Appendix A.

5. Financial Implications

5.1. The total capital programme for Housing and Technical Resources (HRA) for 2008/2009 is £38.543million. Anticipated spend to date was £31.653million, and £30.272million has been spent (78.54% of full budget). This represents a position of £1.381million behind profile. This time last year £28.030million was spent (76.92%).
