Subject: Playscheme Grant Applications

1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - request approval for the allocation of playscheme grants in the East Kilbride area for 2011/2012

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-

(d) Applicant: Moss Out of School Service (PS/EK/4/11)

Amount Awarded: £600

(e) Applicant: Special Needs Adventure Playground (SNAP)

Playscheme (PS/EK/5/11)

Amount Awarded: £400 (summer period only)

(f) Applicant: East Kilbride Universal Connections (PS/EK/6/11)

Amount Awarded: £600

(g) Applicant: Women's Aid South Lanarkshire (PS/EK/7/11)

Amount Awarded: £600

3. Background

3.1. The Council's community grants scheme includes provision for funding for playschemes operating over the Summer, October and Easter school holiday periods. Applications have been invited from individual playschemes for 2011/2012.

- 3.2. The recommendations reflect the Council's decision to allocate grant funding on the following basis:-
 - ♦ £600 to playschemes that operate over the Summer, October and Easter periods
 - ♦ £400 for summer period only
 - ◆ £100 for each of the October and Easter periods
- 3.3. The Council also makes financial provision for individual playschemes to receive, as appropriate, travel passes from Strathclyde Passenger Transport (SPT) and access to Council transport during the school holiday periods.

5. Financial Implications

5.1. The overall total approved by the Executive Committee to support Playschemes and Community Grants in 2011/2012 was £56,000. The proposed grants amounting to £4,000 recommended in this report for approval will be met from the Area Committee's community grants budget. Leaving a balance of £52,000 for the East Kilbride Area Committee.

6. Other Implications

- 6.1. The risks associated with grant support are that the resources provided are not utilised for the purposes for which they were intended. This is mitigated by information received from the application form, the sign off of a Conditions of grant form and by the implementation of an audit process.
- 6.2. There are no significant issues in respect of sustainability in terms of the recommendation in this report.

7. Equality Impact Assessment and Consultation Arrangements

- 7.1. This report does not introduce a new policy, function or strategy or recommend a change to an existing policy, function or strategy and therefore no impact assessment is required.
- 7.2. All the necessary consultation with each national and local group has taken place. Appropriate consultation has also taken place with other Council Resources.
