1 Declaration of Interests

2 Minutes of Previous Meeting

3 Revenue Budget Monitoring 2009/2010 - Lanarkshire Valuation Joint Board

A report dated 28 January 2010 by the Treasurer was submitted comparing the Board's actual expenditure at 22 January 2010 against budgeted expenditure for 2009/2010 and providing a forecast for the year to 31 March 2010.

Following a probable outturn exercise, the forecast to 31 March 2010 was an underspend of £0.056 million. It was proposed that this sum be transferred to Reserves.

The Board decided:

- (1) that the underspend on the Board's revenue budget of £0.065 million at 22 January 2010, as detailed in Appendix A of the report, be noted and;
- (2) that the forecast to 31 March 2010 of an underspend of £0.056 million be noted and the transfer of that sum to Reserves be approved.

5 Performance Standards for Electoral Registration Officers

A report dated 10 February 2010 by the Assessor and Electoral Registration Officer was submitted on an assessment of the performance of the Electoral Registration Officer (ERO) for 2009.

The Electoral Commission had developed a suite of 10 performance measures against which Electoral Registration Officers were required to measure their performance. The 10 performance measures were set out under the following 4 main headings:-

- completeness and accuracy of electoral registration records
- integrity
- participation
- planning and organisation

In respect of the Lanarkshire Valuation Joint Board, the ERO had been assessed as:-

- not yet meeting the performance standard in 2 of the performance measures
- meeting the performance standard in 5 of the performance measures
- above the performance standard in 3 of the performance measures

Completeness and accuracy of electoral registration records was considered by the Commission as the most important of those performance areas. The ERO had met the standard in 2 out of 3 of the performance measures and exceeded the standard in the other of the Commission's required performance measures in this key area.

A detailed plan for maintaining the integrity of registration and absent vote applications would be put in place during 2010. Efforts would continue to allocate resources to put in place a meaningful Public Awareness Strategy. Those actions would allow the ERO to meet the Commission's performance standards at the next assessment.

A 5 year strategic plan for improving the completeness and accuracy of the Electoral Register was being prepared and would be submitted to a future meeting of the Board.

The Board decided: that the report be noted.
