Variance Explanations

Employee Costs

The overspend is due to early retirals within Personnel and Legal Services and is partially offset by vacancies in Legal Services.

Administration Costs
The underspend is within Personnel and represents the expenditure profile of the Leadership Development Programme for the remainder of the year.

Income
The over recovery is partly due to additional income from Sub-lets in Office Accommodation. The remaining over recovery relates to physiotherapy and medicals and is partially offset by additional expenditure in these areas.

Variance Explanations

Employee CostsThe overspend is due to the cost of early retrials across all three Services.

2. Supplies and Services
The underspend is due to reduced expenditure on paper within Printing Services. This will be offset by an under recovery of income.

3. Payments to Other Bodies
The underspend relates to the spend profile of the New Media initiative
