# 6 'Buy with Confidence' Approved Trader Scheme

A report dated 27 April 2011 by the Executive Director (Community Resources) was submitted on the proposed introduction of a 'Buy with Confidence' Approved Trader Scheme to vet traders and improve consumer protection and fair trading within South Lanarkshire.

'Buy with Confidence' was a national approved trader scheme which operated in conjunction with a number Trading Standards Services. Currently, 37 local authorities operated the scheme. It had been endorsed and approved by the Office of Fair Trading and was considered a "best practice" scheme.

Membership of the scheme required a one-off administration fee of £100 to be paid by each local authority. Thereafter, an annual fee would be paid based on the number of member businesses in the local authority area. Currently, the fee was £5 per business.

Businesses would require to pay South Lanarkshire Council's Trading Standards Services an annual fee to become members of 'Buy with Confidence'. The level of fee was likely to be in the region of £175 per annum per member.

As members, South Lanarkshire businesses would benefit from the following:-

 businesses would be advertised on the 'Buy with Confidence' website which consumers could search to find a Trading Standards approved trader

- inclusion on a list of approved traders that Trading Standards would make available to South Lanarkshire consumers
- the provision of scheme logos, marketing and publicity materials to promote the business as a Trading Standards approved business
- promotion of the scheme by the Council's Trading Standards Service

It was proposed that approved contractors currently on the list of approved traders for private sector adaptation work associated with the Scheme of Assistance operated by Housing and Technical Resources be transferred to the 'Buy with Confidence' scheme if they met the approved criteria. The potential also existed to extend the scheme to areas such as the Care and Repair Service and further discussion would be undertaken with the Care and Repair Service with a view to progressing this.

#### The Committee decided:

- (1) that the 'Buy with Confidence' Approved Trader Scheme be introduced within South Lanarkshire; and
- that the 8 contractors currently associated with the Scheme of Assistance be transferred to the "Buy with Confidence" scheme subject to them meeting the approved criteria.

## 7 Community Resources - Notification of Contracts Awarded

A report dated 21 April 2011 by the Executive Director (Community Resources) was submitted on contracts awarded by Community Resources during the period 30 October 2010 to 21 April 2011.
