# 2 Minutes of Previous Meeting

# 5 Update of Risk Register for Lanarkshire Valuation Joint Board

A report dated 16 February 2011 by the Assessor and Electoral Registration Officer was submitted on an updated Risk Register and Risk Control Plan for Lanarkshire Valuation Joint Board (LVJB).

A risk workshop had taken place on 29 January 2011 to evaluate the risks associated with the work of the LVJB. As a result of that exercise, 9 new risks had been added to the register and 8 had been removed as they had been concluded or combined with another risk. Details of the new risks were given in the report together with their risk score.

The updated Risk Register and Risk Control Plan were attached as Appendices 1 and 2 to the report respectively.

## 6 Electoral Commission Performance Standards

A report dated 1 February 2011 by the Assessor and Electoral Registration Officer was submitted on an assessment of the performance of the Electoral Registration Officer (ERO) for 2010.

The Electoral Commission had developed a suite of 10 performance measures against which EROs were required to measure their performance. The 10 performance measures were set out under the following main headings:-

- completeness and accuracy of electoral registration records
- integrity
- participation
- planning and organisation

In respect of Lanarkshire Valuation Joint Board, the ERO had been assessed as:-

- meeting the performance standard in 7 of the performance measures
- above the performance standard in 3 of the performance measures

Where the standards were currently being met, further improvements would be made in an effort to exceed those standards. Performance standard 1, which involved using information sources to verify entries on the Register of Electors and identify potential new electors, had been highlighted as an area where the ERO was close to exceeding the standard.
