5.1. The total capital programme for Corporate Resources for 2007/2008 is £1.603million. Anticipated spend to date was £1.603million, with £0.904million expenditure incurred (56.40% of full budget). This represents a position of £0.699million behind profile. This time last year £0.605million was spent (60.35%).
