2. Project summary

Tell us about your project, what you plan to do, what you plan to spend the money on and where the project will be located.

The project will provide intensive individual support targeted at women offenders who have identified support needs and also contribute to the community re-integration, integrated supervision and monitoring of such offenders.

For risky and vulnerable offenders, a co-ordinated range of services is most likely to reduce the risk to the public, to prevent re-offending and to enable the appropriate reintegration of the offender into the community. Issues such as successful reintegration, meaningful use of time, stable accommodation, employability, etc. are crucial in delivering successful outcomes for the range of support services and public protection services that are put in place around offenders in the community. The intensive support service will not, of itself, be a substitute for the full range of services and monitoring systems that such offenders require, but a complement to them.

As such, this floating support service will work in partnership with the other agencies delivering support and public protection within an agreed multi-agency management plan and also in liaison with the key stakeholders such as the MAPPA Chair, Child and Adult Protection agencies and case managers.

The service will support women offenders who present the most significant risk, complex needs and/or vulnerability.

The service will be centrally coordinated via Justice headquarters and access to the service will be through the officer identified to manage the service. All referrals to the service will be centrally processed and allocated by this officer.

It is the aim of the project to offer a flexible, responsive service 52 weeks of the year to appropriate offenders. In order to achieve this, the service requires the equivalent of three full-time support workers.

The service will be available between 9.00am - 6.00pm every weekday of the year (including public holidays), but will also have the flexibility to be able to operate outside of these hours where agreed within an individual management plan.

- To reduce the risks of homelessness
