---

The Regen:fx Youth Trust Manager gave a presentation on the work of the South Lanarkshire Regen:fx Youth Trust which involved the development, delivery, co-ordination and funding of youth diversion activities and projects designed to engage 10 to 21 year olds, particularly in regeneration areas, with a view to:-

- ◆ reducing anti-social behaviour and youth disorder
- ◆ providing an alternative to drugs and alcohol
- ◆ breaking down territorial barriers

  - ◆ partnership working
  - ◆ involvement of, support to and training of local communities
  - ◆ youth work and sports programmes
  - ◆ public relations and marketing
- ◆ specific diversion projects including:-

  - ◆ Car Project
  - ◆ Hyper-Cyber centres
- ◆ funding allocated to support projects in the Cambuslang and Rutherglen area and the numbers participating in arranged activities
