Subject: Capital Programme of Road Safety Engineering Works

for 2016/2017

1. Purpose of Report

1.1. The purpose of the report is to:-

 inform the Forum of the Capital Programme of Road Safety Engineering Works for 2016/2017 that will contribute to achieving government casualty reduction targets

2. Recommendation(s)

- 2.1. The Forum is asked to approve the following recommendation(s):-
 - (1) that the contents of the Capital Programme of Road Safety Engineering Works for 2016/2017 be noted.

3. Background

- 3.1. The Roads Safety Forum, at it meeting of 8 February 2016, was advised of the provisional number of casualties occurring in the Council area in 2015 and of the trend in casualties with the Scottish Government's casualty reduction targets. It was further advised that, as progress to the 2020 targets is approaching half distance, it can be said that after six years of continuous casualty reduction, the provisional figures, which increased in all categories, remind us that there is still a lot of work to do and that the 2020 targets are challenging.
- 3.2. The Road Safety Forum, at its meeting of 6 February 2013, was advised of the methodology used to identify where road accidents are occurring in South Lanarkshire, how the information is used to prioritise identified accident locations and how these tables are then used to prioritise the Capital Programme of Road Safety Engineering Works. These reports further explained the tried and tested measures that have been employed to assist in casualty reduction to date, as well as their success.

4. Capital Programme of Road Safety Engineering Works for 2016/2017

4.1. Funding of the Capital Programme is provided from three sources: Scottish Government Grant: Cycling, Walking and Safer Streets (CWSS) funding (£346,000), Strathclyde Partnership for Transport (SPT) funding (£225,000) for route action plans on strategic routes and South Lanarkshire Council's Roads Investment Plan (£100,000) for improved infrastructure.

- 4.2. The philosophy that has guided the development of previous Capital Programmes of Road Safety Engineering Works has been continued when developing the 2016/2017 programme (Appendix 1). Targeting locations with casualty records is the main priority, and accounts for approximately 47% of the budget. Other road safety initiatives take up the remaining 53%. The initiatives targeting accident locations are the Route Action Plans and the AIP Single Site schemes.
- 4.3. The other road safety initiatives are:
 - Road Safety Infrastructure Improvements
 - Speed Limit Initiatives
 - Traffic Signals/Pedestrian Crossings
 - Engineering measures at schools
 - Cycle Schemes

5. Financial Implications

5.1. The projects will be financed through the Scottish Government Grant: CWSS (£346,000), SPT funding (£225,000) for route action plans on strategic routes and South Lanarkshire Council's Roads Investment Plan (£100,000) for improved infrastructure.

6. Employee Implications

6.1. The projects will be delivered utilising existing staff resources.

7. Other Implications

- 7.1. There are no significant risks as assessments are carried out using criteria based upon national best practice.
- 7.2. There are no implications for sustainability in terms of the information contained within this report.

8. Equality Impact Assessment and Consultation Arrangements

- 8.1. This report does not introduce a new policy, function or strategy or recommend a change to an existing policy, function or strategy and, therefore, no impact assessment is required.
- 8.2. Consultation will form an integral part of the promotion of the traffic regulation orders required for the new speed limits.
