**4 Civic Government (Scotland) Act 1982 - Licensing of Second-Hand Dealers**

---

A report dated 10 August 2010 by the Executive Director (Corporate Resources) was submitted on proposed amendments and additions to the Council's Resolution on Licensing of Second-Hand Dealers. It was proposed that additional second-hand goods be included in the Resolution as follows:-

- ◆ Motor vehicles, motor spares and parts – add including tyres
- ◆ Motor cycles and parts thereof - add including tyres
- ◆ Furniture - add including mattresses, headboards, pillows and cushions
- ◆ Clothing

It was also proposed that the following amendments be made:-

- ◆ Video recorders and DVD players - amend to audio/video players and recorders
- ◆ Computer hardware and software including hand held computer games – amend to computer hardware, games hardware and related software
- ◆ DVDs, video cassettes and other recording or playback audio mediums – amend to DVDs, CDs and other audio/video playback or recording mediums

In terms of Section 9 of the Civic Government (Scotland) Act 1982, appropriate notice would require to be given in the press for a statutory period of 28 days. On completion of that process, a further report requesting approval of the Final Resolution on Licensing of Second-Hand Dealers would be submitted to Committee.

**The Committee decided:**

- (1) that second-hand dealing in the additional goods listed above be now licensed;
- (2) that the amendments to categorisation of goods, as listed above, be approved; and
- (3) that the draft Resolution on Licensing of Second-Hand Dealers, as detailed in the appendix to the report, be approved.

## **7 Civic Government (Scotland) Act 1982 - Application for Grant of a Late Hours Catering Licence - ROC UK Limited and G Murray, 11 Disraeli Way, East Kilbride in respect of Stonehouse Service Station, Strathaven Road, Stonehouse**

A report dated 4 August 2010 by the Executive Director (Corporate Resources) was submitted on an application for a late hours catering licence in terms of the Civic Government (Scotland) Act 1982.

In terms of the Act, the opportunity of a hearing had been offered to the applicant who was not present but was represented by N Hazard, solicitor, who was heard in support of the application.

Councillor McNeill, seconded by Councillor Filshie, moved that the application be granted. Councillor A M Mitchell, seconded by Councillor McNamee, moved as an amendment that the application be granted for a period of 1 year only. On a vote being taken by a show of hands, 3 members voted for the amendment and 16 for the motion which was declared carried.

#### **8 Civic Government (Scotland) Act 1982 - Application for a Private Hire Car Driver's Licence - A Dunlop, 22 Troon Avenue, Greenhills, East Kilbride**
