Subject: Capital Budget Monitoring 2011/2012 - Education Resources

1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - provide information on the progress of the capital programme for Education Resources for the period 1 April 2011 to 5 August 2011.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
 - (1) that the Education Resources' capital programme of £77.234 million, and expenditure to date of £21.800 million, be noted.

3. Background

- 3.1. This is the first capital monitoring report presented to the Education Resources Committee for the financial year 2011/2012. Further reports will follow throughout the financial year.
- 3.2. The report details the financial position for Education Resources in Appendix A.

5. Financial Implications

5.1. The total capital programme for Education Resources for 2011/2012 is £77.234 million. Anticipated spend to date was £21.114 million with £21.800 million of expenditure being incurred (28.23% of full budget). This represents a position of £0.686 million ahead of profile. This time last year £24.544 million was spent (25.41%).

6. Other Implications

6.1. The main risk associated with the Council's Capital Programme is that there is a significant overspend. The risk has been assessed as low given the detailed project management plans prepared and monitored for each project. The risk of overspend is managed through 4 weekly Investment Management Meetings.

6.2. There are no implications for sustainability in terms of the information contained within this report.
