1. Purpose of Report

1.1. The purpose of the report is to:-

- ◆ Provide an overview of the base data and self assessment template which is used to inform Joint Future submissions evidencing of whole systems working.
- ◆ Highlight South Lanarkshire partnership performance in comparison to the other partnerships across Scotland.

3. Background

3.1. The Scottish Executive Joint Performance Information and Assessment Framework circular CCD 2/2007, dated 14 February 2007, set out the criteria for evaluation of this indicator. This framework enables partnerships to self assess their performance on the whole system approach in broad terms.

3.2. The self assessment is comprised of three elements.

- ◆ Part I Summary: identifies the three levels of evaluation for JPIAF 10
- ◆ Part II Self Assessment Checklist: partnerships are asked to score against one of four assessments of evidence that is available to them
 - No/limited evidence
 - Partially evidenced
 - Well evidenced
 - Comprehensively evidenced
- ◆ Part III Evidencing an understanding of whole systems working: There is a clear requirement to demonstrate an understanding of the relationships between cause and effect and how actions to drive performance relate to wider relationships e.g. prevention, early intervention. There is also a need to show an understanding of the way in which individual indicators relate to each other, an intended direction of travel and how specific actions relate to the analysis of the whole system.

4. Current Position

- 4.1. The South Lanarkshire Partnership, which includes NHS Lanarkshire, carers and service users, performed well last year, moving up six places to third in Scotland.
- 4.2. The JPIAF submission 2006-07 has been submitted.
- 4.3. Figures received illustrate that within South Lanarkshire there is a further increase in the number of people utilising intensive home care services with a subsequent decrease in geriatric longstay and the number of people supported in care homes.
