Subject: Revenue Budget Monitoring 2017/2018 - Detailed

Resource Analysis

1. Purpose of Report

1.1. The purpose of the report is to:-

• update members of the Financial Resources Scrutiny Forum of progress on the Council's revenue budget for the period covering 1 April 2017 to 31 March 2018.

2. Recommendation(s)

- 2.1. The Forum is asked to approve the following recommendation(s):-
 - (1) that the 2017/2018 detailed financial analysis as at period 14 (31 March 2018) for each of the individual Resources be noted.

3. Background

- 3.1. The individual reports attached provide detailed information on each of the Resource Revenue Budgets for 2017/2018 as at 31 March 2018. The detailed papers cover the General Services and also the Housing Revenue Account.
- 3.2. The following information is provided for each Resource and the Housing Revenue Account:
 - An Executive Summary showing the top level position to date for each of the Services (as detailed in the Executive Committee Report) within the Resource and the Housing Revenue Account as at 31 March 2018 (Period 14).
 - Details of the most significant variances within the Resource and the Housing Revenue Account across Subjective headings and across Services as at 31 March 2018 (Period 14).
 - A line by line trend analysis of the total Resource expenditure and income across subjective headings as at 31 March 2018 (Period 14).
- 3.3. These are shown in Appendices A to F attached.

- 6.1. The main risk associated with the Council's Revenue Budget is that there is an overspend. The risk has been assessed as low given the detailed budget management applied across the Resources. The risk is managed through four weekly Budget Monitoring Meetings at which any variance is analysed. In addition, the probable outturn exercise ensures early warning for corrective action to be taken where appropriate.
