3 Application EK/04/0455 – Erection of 3 Stone Benches at Colonsay, East Kilbride

A report dated 12 August 2005 by the Executive Director (Enterprise Resources) was submitted on planning application EK/04/0455 by St Leonard's Community Council for the erection of 3 stone benches at Colonsay, East Kilbride.

9 Planning Application EK/05/0338 – Alterations and Extension to Licensed Premises at 6/12 Langlands Road, Auldhouse, East Kilbride

A report dated 24 August 2005 by the Executive Director (Enterprise Resources) was submitted on planning application EK/05/0338 by IBT for alterations and an extension to licensed premises at 6/12 Langlands Road, Auldhouse, East Kilbride.

The Committee decided: that planning application EK/05/0338 by IBT for alterations and an extension to licensed premises at 6/12 Langlands Road, Auldhouse, East Kilbride be granted subject to the conditions specified in the Executive Director's report.

10 Enforcement Action – Unauthorised Car Repair Business at 86 Jamaica Drive, East Kilbride

A report dated 17 August 2005 by the Executive Director (Enterprise Resources) was submitted on the requirement for enforcement action to terminate the unauthorised operation of a car repair business from a house at 86 Jamaica Drive, Westwood, East Kilbride.

A Planning Contravention Notice had been served on the occupant on 1 April 1998 following complaints regarding the unauthorised car repair business and the number of cars associated with the business being parked within the curtilage and on the street around 86 Jamaica Drive, East Kilbride. A response to the Contravention Notice had been received from the occupant on 12 May 1998 stating that his double garage was used for domestic purposes only.

In response to a number of further complaints, a second Planning Contravention Notice had been served on the occupant on 8 June 2004. The occupant once again stated that the use of the garage was incidental to the enjoyment of the house.

Following a meeting with Planning officers, the occupant agreed to park only 1 vehicle associated with his business at 86 Jamaica Drive, East Kilbride. The situation was monitored by the Planning Service and, initially, showed an improvement. However, the level of parking had since worsened and more complaints had been received.

Operating a business from a residential dwelling could be permitted in certain circumstances. The occupant had been given the opportunity to reduce the scale of his business to an acceptable standard in terms of planning legislation. However, the number of vehicles being parked around 86 Jamaica Drive, East Kilbride was having an adverse impact on the residential amenity and safety of surrounding residents and, therefore, it was proposed to take enforcement action to terminate the unauthorised operation of a car repair business from the house at 86 Jamaica Drive, East Kilbride.

The Committee decided:

- (1) that an Enforcement Notice be served on the occupier of 86 Jamaica Drive, Westwood, East Kilbride requiring him to stop the unauthorised operation of a car repair business at that location; and
- (2) that, in the event that the unauthorised operation was not stopped, authorisation be given for the submission of a report to the Procurator Fiscal.

11 Community Grant Applications
