#### **1** Declaration of Interests

# 3 Secondary Schools Modernisation - Independent Review of Strathaven Academy

A report dated 7 September 2007 by the Chief Executive was submitted on the outcome of the independent review undertaken by PricewaterhouseCoopers, the external auditor, of decisions taken in relation to the Strathaven Academy project.

C Revie, PricewaterhouseCoopers presented the report entitled "Secondary Schools Modernisation – Review of Certain Factors Relating to Strathaven Academy" which:-

- highlighted areas of good practice identified in the course of the review
- put forward key learning points for the Council to consider
- concluded that the overall outcome in terms of Strathaven Academy was likely to remain unchanged

The Chief Executive referred to paragraph 4.5 of his report which indicated that the key learning points highlighted by PricewaterhouseCoopers were accepted.

Various issues in respect of leisure provision costs, pupil safety at Crosshouse Campus and travel risk assessments were raised by members and responded to by officers.

The public meeting to be attended by the Chief Executive and senior officers, as previously agreed by the Council, would be held on Tuesday 25 September 2007 at 7.30pm in the Ballgreen Hall, Strathaven.

#### The Council decided:

- (1) that the report prepared by PricewaterhouseCoopers which concluded that the overall outcome in terms of Strathaven Academy was likely to remain unchanged be noted; and
- (2) that the key learning points be agreed for future appropriate action, in particular:-
  - engagement practices and communication arrangements to be reviewed for the remaining period of the Schools Modernisation Programme and for future initiatives
  - ♦ 50% discount on original charges for alternative sports usage at South Lanarkshire facilities, particularly for outdoor facilities in Hamilton and East Kilbride, to be introduced for Strathaven block bookings and classes with the costs being met from the General Fund

• practice of providing supervisors at transport pick up points for a period following holiday periods to be continued throughout the decant period with the arrangements for bus travel to be kept under review
