## 8 Enforcement Action - Unauthorised Installation of UPVC Windows at 187 High Street, Biggar

A report dated 14 August 2006 by the Executive Director (Enterprise Resources) was submitted on the unauthorised installation of UPVC windows at 187 High Street, Biggar.

Planning consent had been granted on 13 March 2006 for the change of use of café and restaurant to hot food takeaway. However, Condition No 3 of the consent stated that no consent was granted for replacement windows at 187 High Street, Biggar and that a further application required to be submitted for alternative windows.

The owner had been reminded on 2 May 2006 of the requirement to submit proposals for appropriate replacement. However, despite agreement that they would be replaced by 8 August 2006, the windows had not been replaced and the owner had now indicated that he was not in a position to replace them. It was proposed, therefore, that an Enforcement Notice be served to ensure the removal of the unauthorised UPVC windows from the property and their replacement with windows of a style and design appropriate to the Conservation Area.

In response to a question by the Chair, the Area Manager, Planning and Building Standards Services confirmed that a leaflet on Windows and Doors in Listed Buildings and Conservation Areas had been widely circulated to provide appropriate guidance on what was acceptable.

#### The Committee decided:

- (1) that an Enforcement Notice be served on the owner, occupier and/or lessee of 187 High Street, Biggar to ensure the removal of the unauthorised UPVC windows from this property and their replacement with windows of a style and design appropriate to the Conservation Area; and
- (2) that the Notice take effect within 1 month of the date of service with a period of 1 month allowed for compliance.

Councillor McInnes, having declared an interest in this application, withdrew from the meeting during its consideration

A report dated 14 August 2006 by the Executive Director (Enterprise Resources) was submitted on the requirement for a Notice to be served under Section 179 of the Town and Country Planning (Scotland) Act 1997 to secure the removal of demolition material from a site at Biggar Road, Symington.

Outline planning consent had been granted in December 2003 for the redevelopment of a site at Biggar Road, Symington for residential use and the former slaughterhouse on the site had subsequently been demolished. Despite assurances from the current owner that all demolition material would be removed from the site by the end of July 2006, to date the material remained on site. It was proposed, therefore, that a Notice be served to secure the removal of the demolition material.

#### The Committee decided:

- (1) that a Notice under Section 179 of the Town and Country Planning (Scotland) Act 1997 be served on the owner of the site at Biggar Road, Symington requiring them to remove all demolition material and other miscellaneous items from the site: and
- (2) that the Notice take effect within 1 month of the date of service with a period of 1 month allowed for compliance.
