#### 1. Purpose of Report

- 1.1. The purpose of the report is to:-
  - provide employment information for September and October 2008 relating to Corporate Resources

#### 2. Recommendation(s)

#### 3. Background

3.1. As part of the Council's performance management arrangements, regular workforce monitoring reports are submitted to Committee. This report for Corporate Resources provides information on the position for September and October 2008.

#### 4. Monitoring Statistics

Attendance Statistics (Appendix 1)
 Information on absence statistics is analysed for the month of October 2008 for Corporate Resources.

The Resource absence figure for October 2008 was 1.6%, an increase of 0.1% from last month and 2.2% lower than the Council-wide figure. Compared with October 2007, the Resource absence figure has decreased by 0.9%.

Based on the period April 2008 to October 2008, the projected annual absence figure for the Resource is 2.1% as against a Council wide figure of 4.0%. For the Resource this equates to 4.8 days being lost per employee for the year due to absence compared with the figure for the Council of 8.9 days per employee.

#### 4.2 Occupational Health (Appendix 2)

In terms of referrals to occupational health, which include medical examinations and physiotherapy, overall 8 referrals were made this period, an increase of 1 when compared with the same period last year.

#### 4.3 Accident/Incident Statistics

There were no accidents/incidents recorded within the Resource this period. This figure remains unchanged when compared with the same period last year.

#### 4.4 Discipline, Grievance and Dignity at Work

There was 1 disciplinary hearing held within the Resource this period an increase of 1 when compared with the same period last year. There were no grievances or dignity at work cases raised during the period.

#### 4.5 **Analysis of Leavers**

There was 1 leaver in the Resource this period, a decrease of 2 when compared with the same period last year.

#### 5. Staffing Watch (Appendix 3)

5.1 There has been an increase of 5 employees in the period from 14 June 2008 to 13 September 2008.

#### 6. Employee Implications

6.1. There are no implications for employees arising from the information presented in this report.
