2 Unauthorised Tree Felling Within Tree Preservation Order Area at Fernhill School, Fernbrae Avenue, Rutherglen

A report dated 4 June 2007 by the Executive Director (Enterprise Resources) was submitted on unauthorised tree felling which had taken place within a Tree Preservation Order (TPO) area at Fernhill School, Fernbrae Avenue, Rutherglen.

Fernhill School had been advised that no further tree felling should occur and had been requested to provide the Council with a report detailing the trees covered by the TPO, numbered and plotted on a map, together with a description of any further work proposed by the school.

The Tree Survey Report submitted had not included all the information required. Despite a request for further details, those had not been received. Consequently, a Planning Contravention Notice had been served on the Company Secretary of Fernhill School Limited. As the school had yet to provide the requested information, it was proposed that a Tree Replacement Notice be served to rectify the breach of planning control.

The Committee decided: that a Tree Replacement Notice be served on the Company Secretary of Fernhill School Limited to rectify the breach of planning control in respect of the unauthorised tree felling which had taken place within the TPO area at Fernhill School, Fernbrae Avenue, Rutherglen.

3 Playscheme Grant Applications

A report dated 31 May 2007 by the Executive Director (Corporate Resources) was submitted on applications for playscheme grant.

The playscheme funding would allow an allocation of £600 to be made to playschemes that operated over the summer, October and Easter periods with £400 for the summer period only and £100 for each of the October and Easter periods.
