1. Purpose of Report

1.1. The purpose of the report is to:-

- ◆ provide information on the progress of the capital programme for Housing and Technical Resources (excl HRA) for the period 1 April 2008 to 20 February 2009.

- (1) that the Housing and Technical Resources (excl HRA) capital programme of £9.976million, and expenditure to date of £4.735million be noted.

- 3.1. This is the fourth capital monitoring report presented to the Housing and Technical Resources Committee for the financial year 2008/2009.
- 3.2. The report details the financial position for Housing and Technical Resources (excl HRA) on Appendix A.

5. Financial Implications

5.1. The total capital programme for Housing and Technical Resources (excl HRA) for 2008/2009 is £9.976million. Anticipated spend to date was £6.301million, and £4.735million has been spent (47.46% of full budget). This represents a position of £1.566million behind profile. This time last year £4.981million was spent (59.84%).
