Subject: Enterprise Resources - Capital Budget Monitoring

2011/2012

1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - provide information on the progress of the capital programme for Enterprise Resources for the period 1 April 2011 to 5 August 2011.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):
 - that the Enterprise Resources capital programme of £23.965million, and expenditure to date of £4.180million be noted.

3. Background

- 3.1. This is the first capital monitoring report presented to the Enterprise Resources Committee for the financial year 2011/2012. Further reports will follow throughout the financial year.
- 3.2. The report details the financial position for Enterprise Resources in Appendix A.

5. Financial Implications

5.1. The total capital programme for Enterprise Resources for 2011/2012 is £23.965million. Anticipated spend to date was £3.637million with £4.180million of expenditure being incurred (17.44% of full budget). This represents a position of £0.543m ahead of profile. This time last year £4.627million was spent (17.43%).

6. Other Implications

6.1. The main risk associated with the Council's Capital Programme is that there is a significant overspend. The risk has been assessed as low given the detailed project management plans prepared and monitored for each project. The risk of an overspend is managed through 4 weekly Investment Management Meetings.

7. Equality Impact Assessment and Consultation Arrangements
