2 Minutes of Previous Meeting

The Committee decided: that the minutes be approved as a correct record.

The Committee decided: that, in terms of Section 50A(4) of the Local Government (Scotland) Act 1973, the press and public be excluded from the meeting for the following items of business on the grounds that it was likely that there would be disclosure of exempt information in terms of Paragraphs 6 and 14 of Part I of Schedule 7A of the Act.

5 Civic Government (Scotland) Act 1982 (As Amended) - Application for Grant of a Taxi Driver's Licence

A report dated 15 September 2022 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the grant of a taxi driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and heard in support of his application. A late objection had been received from Police Scotland. The reason for the lateness of the objection was accepted and Sergeant Brown was heard on behalf of Police Scotland.

Following discussion, Councillor McGeever, seconded by Councillor Toner, moved that the application be granted for a period of 1 year. Councillor Shearer, seconded by Councillor Corbett, moved as an amendment that the application be refused.

On a vote being taken electronically, 5 members voted for the amendment and 2 for the motion. The amendment was declared carried.

The Committee decided: that the application by W Irvine, 13 Kenmar Road, Hamilton for the grant of a taxi driver's licence in the Hamilton zone be refused.

The Committee decided: that the application by W Rodger, 174 Wilton Road, Carluke for the grant of a taxi driver's licence in the Clydesdale zone be refused.
