3. Background

- 3.1. The Council's Improvement Plan which had been developed in order to respond effectively to issues highlighted in the report on the Audit of Best Value and Community Planning of South Lanarkshire Council sets out a specific action to "make scrutiny and decision making more open and transparent by implementing good practice guidance and by having scrutiny forums in public".
- 3.2 The Executive Committee at its meeting held on 8 July 2009 approved a report proposing a number of amendments to the Council's member scrutiny forum arrangements. One of the proposals involved combining the former Capital Budget, Revenue Budget and the Trading Services Scrutiny Forums into a single scrutiny forum.
- 3.3 One of the key changes to note is that the new Financial Resources Scrutiny Forum will be held in public. Other changes related to the membership which was to be drawn from outwith the Executive Committee and the appointment of a Chair from the opposition groups.
- 3.4 The report to the Executive Committee also outlined the powers and responsibilities of the Forum. The Terms of Reference for this Forum, as agreed by the Executive Committee, are attached for members' information.

Financial Resources Scrutiny Forum

1 Powers and Responsibilities

- 1.1 To scrutinise critically all of the Council's budgets and make recommendations, where appropriate, on any redeployment of resources.
- 1.2 To consider issues arising from trends in Service spending.
- 1.3 To raise any issues in respect of the Council's financial management arrangements.
- 1.4 To review financial and operational progress on the Council's capital programme.
- 1.5 To consider the preparation of future years' capital programmes.
- 1.6 To research alternative funding methods.
- 1.7 To review financial and operational progress by the Council's Trading Services.
- 1.8 To consider any relevant policy matters in the operation of the Council's Trading Services

2 Membership

- 2.1 9 Members (Political balance: 4 Labour; 3 SNP; 1 Con; 1 Ind/Lib Dem). Membership would be drawn from members not on the Executive Committee with the exception of the Chair who would be an opposition councillor
- 2.2 Quorum 3.

3 Meeting Arrangements and Practice

- 3.1 From April to August, to meet every 8 weeks and from September to March, to meet every 4 weeks.
- 3.2 To report through the Executive Committee.
