Subject: Blacklaw Renewable Energy Fund – Update Report and

Grant Application for Law Community Trust

1. Purpose of Report

1.1. The purpose of the report is to:-

- Consider an application to the Blacklaw Renewable Energy fund from Law Community Trust for additional financial assistance towards the upgrading and refurbishment of an existing play park
- ◆ Report on Blacklaw Renewable Energy Fund grants awarded to date since its inception.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):
 - that an additional grant be awarded to Law Community Trust of up to £8,119 towards upgrading and refurbishment of an existing play park.
 - (2) that the grant awards from the Blacklaw Renewable Energy Fund since inception be noted.

3. Background

- 3.1. At the Executive Committee of 3 March, 2004, approval was given to set up a Renewable Energy Fund in respect of Blacklaw Windfarm and to administrative arrangements associated with the allocation of funds.
- 3.2. The Fund is financed from payments from Scottish Power who operate the Blacklaw Windfarm. To date Scottish Power have made payments into the Fund totalling £607,868 including interest.
- 3.3. The Renewable Energy Fund is administered by Enterprise Resources who have responsibility for advising potential applicants, assessing applications and monitoring projects to ensure that the community benefits associated with each project are delivered.
- 3.4 This report seeks approval for an additional grant to be awarded to Law Community Trust and gives an update on total approvals to date.

4. Proposal

Law Community Trust

- 4.1. Law Community Trust is a registered charity (est. 1999) which aims to improve the well being, civic pride and social cohesion of the community of Law.
- 4.2. The project involves the upgrading of the existing play park with new equipment. An adjacent car park will be improved to ensure families from all areas of the village are able to access the park with their children. At the Enterprise Resources Committee meeting on 20 May 2009, a grant of £30,000 was awarded to the Trust for this project.
- 4.3. The total eligible cost of the project is £76,268. The existing grant of £30,000 equates to an intervention rate of 35%. Law Community Trust has confirmed funding of £30,000 from Forward Scotland and an in-kind contribution of £16,268 from Community Resources towards the project. A further funding application for £10,000 to the Robertson Trust was rejected.
- 4.4 Due to the rejection from the Robertson Trust, Law Community Trust are seeking an increase in Renewable Energy Fund grant of up to £8,119 in order to complete the project to a high standard. This would increase the grant intervention level to 50%.
- 4.5. The project will be project managed by Community Resources who will report to a committee of Law Community Trust. Following completion, the play park will be managed and maintained on an ongoing basis by Community Resources within existing budgets. It is expected that works would commence on site in spring 2010 and be completed by summer 2010.
- 4.6. This application scored 28 from a possible total of 32 during the assessment process. This score permits an intervention level of up to 50%.

5. Projects Approved to date by Blacklaw Renewable Energy Fund.

5.1. A list of all projects supported to date by the Blacklaw Renewable Energy Fund is attached. Appendix A lists those capital projects with overall costs above £10,000 and which are supported through the main fund. Appendix B lists those capital projects with overall costs below £10,000 and which are supported through the Local Grant Scheme, managed through the EU funded LEADER Programme.

7. Financial Implications

- 7.1. To date Scottish Power have made payments into the Blacklaw Fund of £607,868 including interest.
- 7.2. Blacklaw has already committed funds, from the main Fund, of £386,928 towards projects from an available budget of £425,507 (70% of the total £607,868 which has been allocated to the REF). There are sufficient funds available therefore to meet the total of £8,119 requested.
- 7.3. The Local Grant Scheme (30% of the total £607,868) has awarded grants of £121,238 from an available budget of £182,360.
