7 Air Quality Management Area - Rutherglen

A report dated 13 November 2015 by the Executive Director (Community and Enterprise Resources) was submitted proposing that the Rutherglen area be declared by official Order as an Air Quality Management Area (AQMA).

The procedures to be followed to declare an area as an AQMA had been reported to the Community Resources Committee on 3 June 2008. Those procedures had included the requirement for a period of public consultation. In the course of the public consultation, no objections had been received and it was, therefore, now proposed that the Rutherglen area be declared by Order as an AQMA with a commencement date of 1 January 2016.

The Committee decided:

(1) that the following Order be made to declare the Rutherglen area, as detailed on the map contained in Appendix A to the report, as an Air Quality Management Area with a commencement date of 1 January 2016:-

"South Lanarkshire Council in exercise of the powers conferred upon it by Section 83 (1) of the Environment Act 1995, hereby makes the following Order.

This Order may be referred to as the South Lanarkshire Air Quality Management Area No 2 (Rutherglen) and shall come into effect on 1 January 2016.

The area shown on the plan marked in black is to be designated as an Air Quality Management Area (the designated area).

This area is designated in relation to a likely breach of Particular Matter less than 10 microns (PM10) objectives, as set out in the Air Quality (Scotland) Regulations 2000, as amended. The PM10 air quality objective is that, the concentration of PM10 when expressed as a 24 hour mean must be 50 micrograms per cubic metre or less and that the 50 micrograms per cubic metre concentration is not exceeded more than 7 times per year. In addition, the PM10 concentration when expressed as an annual mean must be 18 micrograms per cubic metre or less.

This Order shall remain in force until it is varied or revoked by a subsequent Order.

8 Air Quality Management Area - Lanark

The Committee decided:

(1) that the following Order be made to declare the Lanark area, as detailed on the map contained in Appendix A to the report, as an Air Quality Management Area with a commencement date of 1 January 2016:-

"South Lanarkshire Council in exercise of the powers conferred upon it by Section 83 (1) of the Environment Act 1995, hereby makes the following Order.

This Order may be referred to as the South Lanarkshire Air Quality Management Area No 3 (Lanark) and shall come into effect on 1 January 2016.

The area shown on the plan marked in black is to be designated as an Air Quality Management Area (the designated area).

This area is designated in relation to a likely breach of nitrogen dioxide objectives, as set out in the Air Quality (Scotland) Regulations 2000, as amended. The nitrogen dioxide air quality objective is that, the concentration of nitrogen dioxide when expressed as a 1 hour mean must be 200 micrograms per cubic metre or less and that the 200 micrograms per cubic metre concentration is not exceeded more than 18 times per year. In addition, the nitrogen dioxide concentration when expressed as an annual mean must be 40 micrograms per cubic metre or less.

This Order shall remain in force until it is varied or revoked by a subsequent Order.

9 Update on the Community and Enterprise Resources' Risk Register and Risk Control Action Plan

A report dated 18 November 2015 by the Executive Director (Community and Enterprise Resources) was submitted on:-

- systems and controls in place within Community and Enterprise Resources to control and minimise risks
- details of Community and Enterprise Resources' current Risk Control Register

The Resource had followed Council guidance in developing, monitoring and updating its Risk Control Register on an ongoing basis. The Register had been developed to ensure that the Resource was fully aware of the main risks that it had, was able to prioritise those risks and had controls in place to eliminate or minimise the impact of the risk.

The risks were scored in accordance with the Council's scoring mechanism which scored risks based on likelihood and impact of risk. This resulted in risks being scored between 1 to 9 (low to high). Risks were scored on their inherent risk (risk if nothing was done) and their residual risk (risk after applying controls).

The Risk Register for the Resource had been developed and was monitored on a quarterly basis to add new risks and to review the scores of existing risks. The Register was maintained within the Corporate Risk Management Figtree computer system and updated by designated officers within Community and Enterprise Resources.

The Committee decided:	that the systems and controls in place to monitor risks
	within Community and Enterprise Resources be noted.
