1 Declaration of Interests

2 Minutes of Previous Meeting

The minutes of the meeting of the Roads Safety Forum held on 4 February 2015 were submitted for approval as a correct record.

3 Education, Training and Publicity Initiatives

A report dated 1 May 2015 by the Executive Director (Community and Enterprise Resources) was submitted on the range of road safety education, training and publicity initiatives being undertaken in South Lanarkshire.

- (1) that the road safety education, training and publicity initiatives being undertaken in South Lanarkshire, as detailed in the report, be noted; and
- (2) that future road safety education, training and publicity initiatives in South Lanarkshire be supported.

4 Revised School Crossing Patroller Assessment Criteria

A report dated 14 April 2015 by the Executive Director (Community and Enterprise Resources) was submitted on revised criteria for assessing requests for school crossing patrollers for locations which predominantly served secondary schools.

Current requests for school crossing patrollers were assessed using criteria broadly based on national best practice.

As part of the Council's efficiencies budget settings exercise, the removal of 20 school crossing patrollers, serving predominantly secondary schools, had been approved, subject to appropriate risk assessments. Assessment criteria had been revised to reflect that school crossing patrollers would only be approved at locations serving predominantly secondary schools where a defined need had been established, based on particular road safety risks.

The Forum decided: that the revision to the criteria for assessing requests for school crossing patrollers, as detailed above, be noted.

5 School Crossing Patrol Assessments

A report dated 14 April 2015 by the Executive Director (Community and Enterprise Resources) was submitted on a request for school crossing patrols at 3 locations within South Lanarkshire, 2 of which had been assessed in terms of the Council's approved criteria and 1 in terms of the revised criteria.

The following locations had failed to meet the Council's criteria:-

- Croft Road at Johnson Drive, Cambuslang
- Netherton Road, East Kilbride

Townhead Street at Bowling Green, Strathaven had failed to meet the revised criteria for sites serving predominantly secondary pupils.

The Forum decided: that the refusal of the requests for crossing patrols at the 3

locations detailed above, which had failed to meet the Council's criteria and revised criteria for sites serving predominantly

secondary school pupils respectively, be supported.

6 Kerbcraft Road Safety Training Initiative

A report dated 21 April 2015 by the Executive Director (Community and Enterprise Resources) was submitted on the progress of the Kerbcraft Road Safety Training Initiative within South Lanarkshire.

5 primary schools had completed the Kerbcraft Training during the period August to December 2014.

The Forum decided: that the Kerbcraft Road Safety Training Initiative being undertaken

in South Lanarkshire, as detailed in the report, be noted.
