1 Purpose of Report

1.1 The purpose of the report is to:-

 provide employment information for the period April to June 2013 relating to Enterprise Services

3 Background

3.1 As part of the Council's performance management arrangements, regular Workforce Monitoring Reports are submitted to Committee. This report for Enterprise Services Committee provides information on the position for the period April to June 2013.

4 Monitoring Statistics

4.1 Attendance Statistics (Appendix 1)

Information on absence statistics is analysed for the most recent month of June 2013 for Enterprise Services.

The absence figure for June 2013 was 3.7%, a decrease of 0.1% when compared with last month and is 0.1% higher when compared with the Council wide figure. Compared to June 2012, the absence figure remains unchanged.

Based on absence figures from April to June 2013 the projected average absence figure for the financial year 2013/2014 is 4.5% compared to a Council wide projected average of 4%.

Based on the period April to June 2013, the projected average number of days lost per employee due to absence was 10.4 days, compared with the figure for the Council of 9.2 days.

4.2 Occupational Health (Appendix 2)

In terms of referrals to occupational health, which include medical examinations and physiotherapy, overall 64 referrals were made this period, an increase of 12 when compared to the same period last year.

4.3 Accident/Incident Statistics

There were 20 accidents/incidents recorded this period, an increase of 7 when compared with the same period last year.

4.4 Discipline, Grievance and Dignity at Work

There were 9 disciplinary hearings held this period, a decrease of 1 when compared with the same period last year. There were no grievances or dignity at work hearings held this period.

4.5 **Analysis of Leavers**

There were 7 leavers this period, an increase of 5 when compared with the same period last year. Exit interviews were held with 2 of those employees.

5 Financial Implications

5.1 All financial implications are accommodated within existing budgets.

6 Other Implications

6.1 There are no implications for sustainability or risk in terms of the information contained within this report.
