Subject: Governance of Trust Funds - 2010/2011 Expenditure

1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - ♦ Inform Committee of the payments made to beneficiaries from the trust funds administered by the Council.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
 - (1) that the contents of this report are noted.

3. Background

- 3.1. South Lanarkshire Council administers a total of 110 Trust Funds. The value of these Trust Funds as at 1 April 2010 was £0.864m.
- 3.2. These Trusts are primarily the result of bequests which have gifted varying sums of money to the Council for specific purposes such as assisting the poor, or to provide prizes in schools.
- 3.3. In a report to Finance and Information Technology Resources Committee in January 2010, it was agreed that an annual report on the financial position of trust funds would be provided, advising of monies distributed and remaining balances within Trusts. This paper is intended to fulfil that commitment.

4. Summary of Financial Position for 2010/11

- 4.1. The opening balance of the trust funds as at 1 April 2010 was £0.864m.
- 4.2. During 2010/11 expenditure totalled £0.040m of which £0.038m was distributions to beneficiaries of the trust funds. The remaining £0.002m was fees payable for the management of the Loudon Bequests investment portfolio.
- 4.3. The expenditure was partly offset by income of £0.031m, resulting in a deficit of £0.009m and a closing balance on the funds of £0.855m
- 4.4. Appendix 1 details the payments made to beneficiaries and the remaining balances of the funds.

5. Ongoing Governance of Trusts

- 5.1. The Finance and Information Technology Resources Committee will continue to act as the governing body of the Trusts. Annual reports will be presented to Committee advising of monies distributed and remaining balances within Trusts. The Chief Executive will act on behalf of the Committee in administering the Trusts and any changes to the beneficiaries will be notified to the Chair and relevant local members.
- 5.2. The recipients of the Education Trust Funds are deemed to be the schools. The selection of individual prize winners is administered by the schools.
- 5.3. The Council is also required to submit a report each year to the Office of the Scottish Charity Regulator (OSCR), including both the accounts for the trust, and also an Annual Report including information on the performance, governance and outcomes of the Trust.

6. Employee Implications

6.1. None.

7. Financial Implications

7.1. All financial implications arising from the Trust review can be met by the Trust Funds.

8. Other Implications

8.1. There is a risk that the funds of the Trusts are not used for the purpose that they were intended. To mitigate this risk, the governance arrangements in place ensure that this Committee is advised of the balance and distribution of funds. In addition OSCR also receive an annual report on the Trusts and their purpose.

9. Equality Impact Assessment and Consultation Arrangements

- 9.1. There is no requirement to carry out an impact assessment in terms of the information contained in this report.
- 9.2. There is also no requirement to undertake any consultation in terms of the information contained in this report.
