2 Minutes of Previous Meeting

4 Enforcement Action – Unauthorised Erection of 2 Storey Play Hut at 15 Barassie Court, Bothwell

A report dated 12 September 2006 by the Executive Director (Enterprise Resources) was submitted on the unauthorised erection of a 2 storey play hut at 15 Barassie Court, Bothwell.

As a result of a number of complaints received, the owner had been asked to reduce the structure to a single storey and to submit a planning application to regularise the position. However, no planning application had been lodged and no response had been received to a Planning Contravention Notice served on 12 May 2006. It was proposed, therefore, that an Enforcement Notice be served to ensure that the unauthorised structure was removed.

The Committee decided: that an Enforcement Notice be served on the owner,

occupier and/or lessee of 15 Barassie Court, Bothwell requiring them to remove the unauthorised structure with the Notice coming into effect 1 month from the date of service and with a period of 1 month allowed for

compliance with the Notice.
