8 HMle Report - St Bride's Primary School, Bothwell

A report dated 7 November 2006 by the Executive Director (Education Resources) was submitted on the outcome of the inspection of St Bride's Primary School, Bothwell made by Her Majesty's Inspectorate of Education (HMle). The inspection had taken place in June 2006 as part of a national sample of primary education and the inspection report had been published on 24 October 2006.
