### **5 Civic Government (Scotland) Act 1982 (As Amended) – Application for Grant of a Taxi Driver's Licence**

---

A report dated 10 October 2019 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the grant of a taxi driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and heard in support of his application. N Arshad was also heard. A representation had been received from Police Scotland and Inspector McGovern was heard.

Councillor Miller, seconded by Councillor Gray, moved that the application be granted for a period of 1 year. Councillor Carmichael, seconded by Councillor McGuigan, moved as an amendment that the application be refused. On a vote being taken by a show of hands, 4 members voted for the amendment and 16 for the motion which was declared carried.

**The Committee decided:** that the application by W Bashir, 199 Bonnyton Drive, Eaglesham, Glasgow for a taxi driver's licence in the Cambuslang and Rutherglen zone be granted for a period of 1 year.

### **6 Civic Government (Scotland) Act 1982 (As Amended) – Application for Grant of a Private Hire Car Driver's Licence**

---

A report dated 10 October 2019 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the grant of a private hire car driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

At its meeting on 3 September 2019, the Committee agreed that this application be continued to a future meeting to allow the applicant the opportunity to be present.

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was not present or represented. A representation had been received from Police Scotland.

**The Committee decided:** that the application by R Hickinson, 22 Mansefield Crescent, Strathaven for a private hire car driver's licence in the East Kilbride zone be refused.
