# 1. Purpose of Report

3.1. A report dated 10 February 2011 by the Chief Executive was tabled on recommendations which had been referred to this Committee by the Housing and Technical Resources Committee (Special) of 10 February 2011. The recommendations of the Housing and Technical Resources Committee were as follows:-

# Housing Revenue and Capital Account Budget 2011/2012

- that the Revenue Estimate proposals for the Housing Revenue Account Budget 2011/2012, as detailed in the report, and the average weekly rent increase of £2.15 (4%) for Council houses be approved
- that the 4% rise also be applied to the rent of lockups and travelling persons' sites
- that the next stage of rent harmonisation be progressed as detailed in the report
- that the factoring fee be increased from £14.75 to £19.38 per quarter in 2011/2012 rising to £24.00 per quarter in 2012/2013
- that, based on this rent increase, the 2011/2012 Housing Capital Programme of £38.532 million, as detailed in Appendix 2 to the report, be approved

#### 5. Recommendations Referred by Executive Committee (Special) – Capital Programme 2011/2012 to 2013/2014 – Extract of Minute

5.1. A report dated 4 February 2011 by the Chief Executive was submitted on the Capital Investment Programme for General Fund services for 2011/2012 to 2013/2014.

The Capital Programme funding package totalled £62.101 million over the 3 financial years. Grant funding totalling £40.317 million had been confirmed and assessed and a programme to utilise this level of funding had been developed. Also included within the overall total was an amount of £21.784 million to cover the impact of projects which had been accelerated or had experienced slippage during 2010/2011.

Details of the General Fund Capital Programme 2011/2012 to 2013/2014 were provided in an appendix to the report.

- (1) that the Capital Programme funding package for the years 2011/2012 to 2013/2014, as detailed in the report, be approved; and
- (2) that the proposed programme of General Fund capital projects for financial years 2011/2012 to 2013/2014, as detailed in the appendix to the report, be approved.
