2 Minutes of Previous Meeting

The minutes of the meeting of the Licensing Committee held on 4 May 2021 were submitted for approval as a correct record.

The Committee decided: that the minutes be approved as a correct record.

4 Exclusion of Press and Public

The Committee decided: that, in terms of Section 50A(4) of the Local Government (Scotland) Act 1973, the press and public be excluded from the meeting for the following items of business on the grounds that it was likely that there would be disclosure of exempt information in terms of Paragraph 14 of Part I of Schedule 7A of the Act.

Councillor Carmichael entered the meeting after this item of business

5 Civic Government (Scotland) Act 1982 (As Amended) – Application for Renewal of Private Hire Car Driver's Licence No 835

A report dated 6 May 2021 by the Executive Director (Finance and Corporate Resources) was submitted on an application for renewal of private hire car driver's licence No 835 in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and heard in support of his application. An objection and subsequent emails had been received from Police Scotland and Sergeant Rankin was heard.

The Committee decided: that the application for the renewal of private hire car driver's licence No 835 in the Cambuslang and Rutherglen zone be refused.

Councillor Greenshields left the meeting during this item of business

6 Civic Government (Scotland) Act 1982 (As Amended) – Consideration of Suspension or Revocation of Private Hire Car Driver's Licence No 277

A report dated 6 May 2021 by the Executive Director (Finance and Corporate Resources) was submitted proposing that consideration be given to whether private hire car driver's licence No 277 should be suspended or revoked.

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the licence holder who was present and heard in support of retaining his licence. A letter of complaint had been received from Police Scotland and Sergeant Rankin was heard.

Councillor Thomson, seconded by Councillor Ferguson, moved that the licence be suspended with immediate effect for a period of 1 year. Councillor McClymont, seconded by Councillor Hamilton, moved as an amendment that the licence be suspended with immediate effect for a period of 6 months. Councillor McLachlan, seconded by Councillor McGuigan, moved as a second amendment that the licence be suspended with immediate effect for the remainder of the period of licence.

On a vote being taken by roll call, between the second amendment (moved by Councillor McLachlan, seconded by Councillor McGuigan) and the first amendment (moved by Councillor McClymont, seconded by Councillor Hamilton), members voted as follows:-
