### 3 Police Scotland - Lanarkshire Division Road Safety Update

A report dated 24 November 2016 by the Local Authority Liaison Officer, Police Scotland was submitted on national and local road safety campaigns.

# 4 West Safety Camera Unit

A Thomson, Unit Manager, West Safety Camera Unit gave a presentation on the Scottish Safety Camera Programme.

Safety cameras were considered to be an integral element of the Road Safety Framework 2020.

On 24 February 2014, Transport Scotland had launched the Scottish Safety Camera Programme consultation, the purpose of which was to gain input from local stakeholders, including road authorities and Police Scotland, on the assessment and selection of sites for safety cameras.

Information was provided on:-

- the aims and goals of the unit which was to change driver behaviour and ensure a greater level of compliance
- the types of safety cameras in operation, their locations and the considerations that went into site selection and the type of camera used
- statistics in relation to camera activations and enforcement

A Thomson responded to members' questions.

# 5 Bikeability Scotland Cycle Training

A report dated 16 November 2016 by the Executive Director (Community and Enterprise Resources) was submitted on the Bikeability Scotland Scheme within South Lanarkshire.

Bikeability Scotland was the brand name for multi-level cycle training in Scotland, designed to give children the skills and confidence to ride their bikes safely on today's roads.

The 3 levels of the Scheme formed part of the Scottish Government's Cycle Action Plan for Scotland (CAPS) and aligned to the National Standard for Cycle Training developed on behalf of the Department for Transport. Responsibility for the administration of the Scottish Cycle Training Scheme lay with Cycling Scotland.

Bikeability Scotland Levels 1 and 2 were co-ordinated and supported by the Council's Traffic and Transportation Section and details were provided on school pupil participation at both levels.

Cycle helmet usage continued to be monitored and the percentage of pupils taking part in Levels 1 and 2 and wearing helmets had increased from 55% in 2005/2006 to 92% in 2015/2016.

Information was also provided on the success of South Lanarkshire Council employees at the Bikeability Scotland Awards and future developments.
