**Subject: Budget Scrutiny Query - Concierge Costs** 

I refer to your memo dated 30 March 2010 regarding the above and can quantify that the level of APT&C Basic pay underspend equates to £73,000 with the level of overtime being £70,000.

In terms of the most up to date position regarding vacancies, two are now filled and two are remaining to be filled (one to be filled by the end of April 2010 and the other being held due to the potential closure of the facility). It is expected that the level of overtime will reduce in 2010/11 as a result of these vacancies being filled, with the position regarding the need for ongoing absence cover under constant review.
