## **3 Modernising Better Government for Older People**

---

The Project Manager, Better Government for Older People gave a presentation on:-

- ♦ the background to Better Government for Older People (BGOP) in South Lanarkshire which had originated from a research project set up by the government in 1998 to engage older people (defined as those aged 50 years and over) in service delivery design and planning and to ensure that information was delivered to them by the most suitable means
- ♦ work undertaken since 2006 to modernise BGOP in South Lanarkshire

- ♦ the main priorities identified by older people involved in BGOP which were:-
  - ♦ transport, housing and surroundings
  - ♦ health, social care and wellbeing
  - ♦ money
  - ♦ active ageing
  - ♦ information
- ♦ current work being undertaken by BGOP
- ♦ South Lanarkshire Older People's Assembly

The Project Manager was commended on her contribution to the success of the project in South Lanarkshire.

#### **4 HMle Report - St Cadoc's Primary School, Cambuslang**

A report dated 22 January 2009 by the Executive Director (Education Resources) was submitted on the outcome of the inspection of St Cadoc's Primary School, Cambuslang made by Her Majesty's Inspectorate of Education (HMle).

The inspection had taken place in November 2008 as part of a national sample of primary education and the inspection report had been published on 27 January 2009.
