Community Resources' Resource Plan 2008/2009

1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - request approval for Community Resources' Resource Plan 2008/2009.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
 - (1) that the key achievements made by the Resource during 2007/2008 are noted, as detailed in Appendix 2 to the Resource Plan 2008/2009;
 - (2) that the Resource Plan 2008/2009 be referred to the Executive Committee for approval; and
 - (3) that a 6 monthly interim progress report be provided in due course.

3. Background

- 3.1. The Resource Plan for 2008/2009 has been prepared based on an agreed corporate structure and style, following guidance received from Solace Enterprises. The Plan is a key element of the Council's performance management arrangements. It provides details of the national and local context within which the Resource operates, and also identifies achievements for the previous year, and establishes objectives and priorities for the new year.
- 3.2 The Resource Plan 2008/2009 embodies where appropriate, the vision, values, objectives and priorities of the Council Plan 2007/2011 'Connect'.
- 3.3 Performance Management is a keystone of Best Value, and ensures that the Council can demonstrate sound governance arrangements. The Resource Plan is one part of the Council's framework for planning and budgeting, and demonstrates how this leads to effective front line service delivery.
- 3.4 As part of this framework the Resource Plan reflects the aspirations of both the Council Plan and the Community Plan, as well as being complemented by the details of individual Service and Business Plans. Ultimately, these details are included in the key work objectives of individual officers. This reflects the 'Golden Thread' of performance management, and demonstrates a clear understanding of the Council's vision, values, objectives and priorities at all levels.
- 3.5 Solace Enterprises worked closely over the past year with each Executive Director and their Resource Management Team in developing the Resource Plans for 2008/2009, and in establishing more robust methods of gathering and reporting

performance. The new format for performance reporting will be used for Executive Directors' reports to the Chief Executive, Resource Management Teams, and to Resource Committees. The focus will be on reporting progress on Council Plan actions, statutory performance indicators and high level Resource priorities, in accordance with a new reporting timetable.

3.6 In preparing the Plan, account has also been taken of the need to ensure a robust response to Risk Management and Control. The risks associated with the activities of the Resource have been identified and evaluated. Those risks which require mitigation are noted in the Resource Risk Control Plan.

4. Resource Plan Detail, Monitoring and Reporting

- 4.2 As part of the performance management arrangements, the Committee will also receive a mid year update of progress on the actions identified in the 2008/2009 Resource Plan.

5. **Progress – 2007/2008**

- 5.1 Overall, of the measures outlined in our 2007/2008 Resource Plan (including statutory performance indicators), we have completed 60 (72%) within the agreed timescales. Progress on all actions is noted at Appendix 2 of the 2008/2009 Plan.
- 5.2. Highlights of the year to date are noted below:-
 - LEAMS score (a national measure of street cleanliness) of 74 against a target of 68 or above
 - Completed the Council's first Sustainable Development Strategy and improvement measures being implemented
 - On target to achieve a 36.9% recycling rate well above the Scottish average of 28%
 - 121,000 households (86% of South Lanarkshire households) now have blue bins
 6,000 more than the target for the year
 - Over 3.5 million attendances across South Lanarkshire Leisure facilities
 - Over 1.7 million attendances at our cultural venues, museums and country parks with 92% customer satisfaction rating
 - 3,618 children attended 'Crucial Crew' community safety event 98% of all primary seven school children across South Lanarkshire
 - Community wings in Carluke and Hareleeshill Primary Schools completed on schedule
 - Lesmahagow and Duncanrig dual use sports facility delivered on schedule
 - Resource absence rate 4.67% against a 5% target
 - South Lanarkshire Lifestyles leisure facility achieved the highest Quest score in Scotland (Quest is an independently assessed quality system)

5.3. There are only 23 measures (28%) that we have not achieved, and these are noted below, together with the reasons why and the management action being taken.
